Ross made a motion to pay the bills. It was seconded by T. Cooper. Yes: Staab, P. Cooper, Ross, T. Cooper, and Hutchison. Nays: None. Motion carried. Ross abstained from voting on payments to Cinda Ross and Kevin Ross.

- VI. New Business:
 - A. Spring Cleanup May 2, 2025 to May 9, 2025: Staab communicated with Waste Connections and set the dates for the Spring Clean Up. Notices went out in the April bills.
 - B. Consider credit to resident sewer fees for February, March, and April: Attorney Kovarik received communication from a resident saying we didn't follow proper procedures for increasing sewer rates at the January 2025 meeting. Kovarik suggested giving a credit for the February, March, and April bills for \$14 per bill per month to put the sewer charge back to what it was prior. Ross suggested a one month credit of \$14 per bill and T. Cooper agreed. Kovarik explained again. Ross made a motion to follow the advice of the attorney and give a credit of \$14 per bill for February, March, and April bills. It was seconded by Hutchison. Yes: Staab, P. Cooper, Ross, and Hutchison. Nays: T. Cooper. Abstain: None. Motion carried.
 - C. Consider sewer fee increase, effective date, and resolution 2025-01 setting fee: P. Cooper made a motion to increase the sewer rate effective on the May 1, 2025 bill to \$36.00 with Resolution 2025-01. It was seconded by Hutchison. Yes: Staab, P. Cooper, Ross, T. Cooper, and Hutchison. Nays: None. Abstain: None. Motion carried.
 - D. De-Obligation Request from USDA: A letter was received from USDA asking if we would De-Obligate \$1000. Ross made a motion to sign the letter to de-obligate the funds. It was seconded by T. Cooper. Yes: Staab, P. Cooper, Ross, T. Cooper, and Hutchison. Nays: None. Abstain: None. Motion carried.
- VII. Unfinished Business:
 - A. 2025 Boundary and Annexation Survey: Attorney Kovarik is working on it.
 - B. Building Regulations and Enforcement: Ross typed up a paper which will be used with new sewer applications.
- VIII. Department/Committee Reports:
 - A. Cerny suggested a note be put with the May bills regarding mowing, Spring clean up, and the credit on previous 3 months for the sewer charge. The board agreed.
 - B. M. Hutchison mentioned he had mowed.
 - C. Ross mentioned that sewer system worked this past month.
- IX. Public Comments:
 - A. Melanie Claflin was present and wants to purchase lots in McGrew and build a building on it. She gave blueprints to Ross. Ross and T. Cooper will look into it.
- X. Adjournment: There being nothing further to discuss, Chairman Staab adjourned the meeting at 7:45.
