#### V. New Business:

- A. Annual Review of Employees: It was discussed that all employees are doing a good job.
- B. Wage Increase for Clerk: Increasing the wage for the clerk was discussed. Staab made a motion to increase Cerny's pay to \$900 per month with a second by Doty. Yes: Ross, Doty, Cooper, and Staab. Nays: None. Motion carried.
- C. Continuing Education Pay for Clerk: Staab made a motion to pay \$400 to the clerk after she completed the required annual continuing education with a second by Cooper. Yes: Ross, Doty, Cooper, and Staab. Nays: None. Motion carried.
- D. Annual Review of Service Charges: It was discussed and will remain the same.
- E. List of Past Dues: A list was presented to the board with a list of McGrew residents that currently owe more than \$200. Staab made a motion for Cerny to write a letter to residents who owe more than \$200 sent by regular and certified mail saying they need to pay their balance in full by January 15, 2022, or a lien will be placed on their property. It was seconded by Doty. Yes: Ross, Doty, Cooper, and Staab. Nays: None. Motion carried.
- F. Reappointment of Jeff Wolfe as Street Superintendent for 2022: 2022 Street Superintendent was discussed. Cooper made a motion to appoint Jeff Wolfe of MC Schaff as the street superintendent during January 1 thru December 31, 2022, for the purpose of the 2022 calendar year Highway Incentive Payment, to be issued to the village by the Nebraska Department of Transportation. It was seconded by Doty. Yes: Ross, Doty, Cooper, and Staab. Nays: None. Motion carried.

## VI. Unfinished Business:

- A. McGrew Improvements using Keno Funds: Improvements were discussed. Ross will get bids to remodel the kitchen and office in the Community Center. Cooper will get bids to chip seal the street.
- VII. Maintenance/Safety Report: Virgil Hagel was present and discussed some maintenance duties he had performed. They included Christmas lights, street lights, stop sign, display case, filling holes, and mowing. He also discussed moving rock and fixing flag holder brackets.

## VIII. Clerk Report:

- A. Pink Palace Tobacco License. Cerny got application and payment for a Tobacco License for the Pink Palace. She made the Tobacco License and delivered it.
- B. Continuing Education: Cerny has finished 5 out of the required 8 hours needed for continuing education.

- C. Michael Olsen MC Schaff Annual Needs Survey for Clean Water. Cerny has been in contact with Michael Olsen from MC Schaff to get a form filled out.
- D. Community Room Rental Rented Thanksgiving/Reserved for Christmas Eve. Cerny mentioned that the Community Room was rented on Thanksgiving and will be rented again on Christmas Eve.
