#### VI. New Business:

- A. Reappoint Jeff Wolfe as Street Superintendent for 2025: Staab made a motion to reappoint Jeff Wolfe as Street Superintendent for 2025. It was seconded by Doty. Yes: Ross, Staab, Doty, and P. Cooper. Nays: None. Abstain: T. Cooper. Motion carried.
- B. Recognize Reelected Board Member: Ross recognized Penny Cooper for being reelected to the board.
- C. Change Internet from Vistabeam to Fiber Optic: Ross mentioned changing from Vistabeam to Q.com. Staab made a motion for Ross to get more information for the next meeting. It was seconded by P. Cooper. Yes: Ross, Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried.
- D. Past Due Accounts: Cerny mentioned that there are a few people who are behind in paying their utility bill. Staab made a motion to send people a letter that are behind six months or more giving them a month to pay their bill or a special assessment will be put on their property at the courthouse. It was seconded by T. Cooper. Yes: Ross, Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried.
- E. Annual Review of Service Charges: Cerny explained what the current utility charges are for sewer and trash. Staab made a motion to reevaluate the charges after hearing from MC Schaff. Mike from MC Schaff should be at the January meeting. It was seconded by P. Cooper. Yes: Ross, Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried.
- F. Review Clerk Performance and Education Requirements: Cerny has completed her continuing education and is appreciated.

#### VII. Unfinished Business:

A. Discussion of Repayment from USDA for Sewer Jetting and Inspection: Mike at MC Schaff wasn't present at the meeting but gave T. Cooper something to present. T. Cooper said that Mike at MC Schaff suggests that the sewer charge be increased to \$78 per month per utility bill if there is no grant or \$35 to \$40 per month per utility bill with a grant.

### VIII. Department/Committee Reports:

- A. Attorney Kovarik explained the procedures for a vacancy in the board which was from Doty. Clerk will post the vacancy in three places. It will be discussed at the January meeting. Two weeks later there will be another meeting to approve a new board member.
- B. Ross mentioned that he has been working on the sewer pump.
- C. Cerny mentioned that she will be working on the Tobacco license this month.
- D. Cerny mentioned that she asked the Nebraska clerks if anyone had Christmas lights they wanted to sell. There were five responses with two being close. They are Oshkosh and Hemmingford. P. Cooper is going to contact them to see if McGrew would like to replace our lights with other town's lights.
