  - c. Maintenance: T. Cooper made a motion for the wage for maintenance work by Ross and Virgil Hagel be increased to \$17 per hour effective immediately. It was seconded by Staab. Yes: Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried. Kevin Ross refrained from voting.
- D. Office Furniture: Cerny found a used desk and bookshelf for sale on Facebook Marketplace for the remodeled office for \$175. Ross purchased it. Staab made a motion to reimburse Ross \$175 for the desk and bookshelf. It was seconded by P. Cooper. Yes: Ross, Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried.
- E. Stove: Purchasing a new or used stove for the kitchen in the community center was discussed. T. Cooper made a motion to purchase a new basic stove for the kitchen in the community center. It was seconded by Staab. Yes: Ross, Staab, Doty, T. Cooper, and P. Cooper. Nays: None. Motion carried.
