 - Vice Chairman: T. Cooper made a motion to appoint P. Cooper as Vice Chairman. It was seconded by Staab. Staab made a motion to cease nominations. Roll Call Vote: P. Cooper = abstain, Staab = yes, Ross = abstain, and T. Cooper = yes. Motion carried.
 - c. Staab made a motion for Ross to finish the meeting. It was seconded by P. Cooper.
- C. Ladonna Rexus cat problem: Ladonna Rexus had concerns about the feral cats. She has been feeding and watering them. T. Cooper wouldn't recommend feeding and watering them. P. Cooper will contact Jeni Mattern at City of Terrytown to see how they handle feral cats.
- D. Ladonna Rexus street signs: Ladonna Rexus mentioned that the street signs are difficult to read. Staab made a motion to look into getting new street signs. It was seconded by T. Cooper. Yes: Ross, Staab, T. Cooper, and P. Cooper. Nays: None. Motion carried.

VII. Unfinished Business:

- A. Change Internet from Vistabeam to Fiber Optic: Fiber Optic is not available at the community center's address yet.
- B. Discussion of Repayment from USDA for Sewer Jetting and Inspection: Mike Olson from MC Schaff wasn't present. No action taken.
- C. Discuss Change in Sewer Utility Charges: P. Cooper made a motion to increase the sewer portion of the utility bill to \$36.00 per month. It will be Resolution 2025-01. It was seconded by Staab. Roll Call Vote: Ross = yes, P. Cooper = yes, T. Cooper = yes, and Staab = yes. Motion carried.

VIII. Department/Committee Reports:

- A. Ross has been working on the sewer.
- B. Cerny has only received one past due payment and confirmed with the board that the others will receive a special assessment from Scotts Bluff County.
- C. T. Cooper mentioned that he invoices being mailed out said "water". Cerny will change it to "sewer".
- D. Cerny mentioned that the quarterly reports are completed. She still needs to do W2s and 1099s.
- E. P. Cooper mentioned that she called two towns about Christmas lights but hasn't heard back.
